### ARTICLE 1 – LICENSED WORK

All copyrights, neighboring rights, and publishing rights are exclusively owned by the Licensor.

### ARTICLE 2 – PURPOSE

The Licensor grants the Licensee a **NON-EXCLUSIVE synchronization license** to use the musical work **ANOTHER BRIGHT DAY UKRAINE** in combination with fixed or moving images, solely for audiovisual productions.

### ARTICLE 3 – NON-EXCLUSIVITY

- Advertising and promotional content
- Web & digital platforms (websites, streaming, social media)
- Corporate and institutional media
- Internal or public broadcasts
- Use is strictly limited to the audiovisual production declared by the Licensee.

## ARTICLE 5 – TERRITORY

The license is granted for exploitation in:

France  Europe.  Worldwide

(as defined in commercial terms)

## ARTICLE 6 – TERM

The license is granted for a duration of:

1 year  3 years  Unlimited

(as defined in commercial terms)

## ARTICLE 7 – FINANCIAL TERMS

This license is granted in consideration of:

- a **synchronization fee (sync fee)** agreed between the Parties, and/or
- **royalties** based on the exploitation of the synchronized work, as defined in an annex if applicable.

### **Public performance rights are excluded.**

All collective management organization fees (SACEM or equivalent) remain payable by broadcasters and users in accordance with applicable law.

## ARTICLE 8 – INTELLECTUAL PROPERTY

No transfer of ownership is granted.

The Licensor remains the sole owner of all intellectual property rights in the Work.

Any use outside the scope of this Agreement requires prior written consent from the Licensor.

## ARTICLE 9 – CREDITS

## ARTICLE 12 – GOVERNING LAW

This Agreement is governed by **French law**.

Any dispute shall fall under the jurisdiction of the courts of the Licensor's registered office.
